Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

- 4. Pre-bid meeting shall be held at *Mahakali Municipality*, *Office of Municipal Executive* at 14:00 hours on 2075/12/16.
- 5. Sealed or electronic bids must be submitted to the office *Mahakali Municipality*, *Office of Municipal Executive* by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before *12:00 hours* on *2075/12/27*. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on 2075/12/27 at the office of *Mahakali Municipality,Office of Municipal Executive*. Bids must be valid for a period of 90 after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
