## Invitation for Bids for procurement of Fabricated Steel Parts for Short Span Trail Bridges (SSTB)

- 1. The **Mahakali MC** has allocated its funds for Trail Bridge Program to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Short Span Trail Bridges (SSTB). Bid is open to all eligible Nepalese Bidders.
- 2. **Mahakali MC, Darchula** invites sealed bids from registered fabricators for supply of fabricated steel parts for following Short Span Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
- 3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years and enlisted by DoLIDAR are eligible for bidding. New fabricators may also apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLIDAR may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
- 4. Eligible Bidders may obtain further information and inspect the bidding documents at the **Mahakali MC, Darchula**, phone no: **093-420137** or may visit PPMO website **www.bolpatra.gov.np/egp.**
- 5. A complete set of Bidding Documents may be purchased from the office:
  - Mahakali MC Office, Darchulaby eligible Bidders on the submission of a written application, along with the copy of company / firm registration certificate and upon payment of a non-refundable fee of *NRs 3,000 (Three thousand)* till Poush 24, 2075 (08<sup>th</sup> January 2019 AD), 5:00 hrs. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs 1,000 (one thousand). However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

May download the bidding documents for e-submission from **PPMO's WebSite www.bolpatra.gov.np/egp**. Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 6. The Bidders who choose to submit their bids electronically through E Procurement Section of PPMO website www.bolpatra.gov.np/egp, may either purchase the hard copy of Bidding Documents or may choose to download the necessary sections of the Bidding Documents, prepare their bids and submit their electronic bids as specified in the Instruction to Bidders. In the case, bidders choose to download and submit bids electronically, the Bidders shall deposit the non-refundable fee of Bidding Documents as specified above either by direct deposit or by Tele-transfer and must submit scanned electronic copy (pdf format) of the bank deposit voucher or Tele-transfer certificate along with the electronic bid files.
- 7. Bids must be submitted to the Mahakali MC Office, Darchula on or before 12:00 noon on Poush-25, 2075 (09th Janaury-2019 AD). Alternatively, Bidders may submit their bids electronically through E Procurement Section of PPMO's website www.bolpatra.gov.np/egp, as specified in the Instruction to Bidders. Documents received after this deadline shall not be accepted and registered.
- 8. Bids shall be opened physically and electronically immediately after the bid submission deadline on Poush-25, 2075 (09th Janaury-2019 AD), 14:00 Hrs in presence of Bidder's representatives who choose to attend at the Mahakali MCOffice, Darchula. Bids must be valid for a period of 90 days after the deadline for bid submission date and must be accompanied by bid security, amounting to a minimum of sum mentioned in the table given below, which shall be valid for 30days beyond the bid validity period.
- If bidder wishes to submit the Bid Security in the form of cash, the bidder has to deposit cash in Deposit Account No: 4090304018102 of Mahakali MC, Darchula in RastriyaBanijya Bank, Darchula and submit bank deposit voucher along with the bid.

- 10. If the last date of purchasing, submission and opening falls on government holiday then the next working day shall be considered as the last day.
- 11. Pre-bid Meeting shall be held at the **Mahakali MC Office**, **Darchula**, on Poush-12, 2075 (27<sup>th</sup> **December**, 2018 AD) at 12:00 noon. Detail information about submission process of bids electronically (e-submission) shall be provided to all interested bidders who chose to attend this pre-bid meeting.
- 12. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
